March is food shelf month and PLC collected 80 pounds of food and an additional \$715.14 for our local food pantry!


The church office was kept busy coordinating daily and weekly activities, preparing for worship services, baptisms, and funerals. Creating bulletins, reports, flyers, and so much more.

We have adapted to this time in varied ways. For instances, though our worshipping body is growing it is not yet where it was. That being said we have moved to one service on Sunday mornings. I know this isn't ideal for everyone but it has provided a more robust and fuller sanctuary for worship. There has also been a large increase in Sunday School age youth and families coming to worship on Sunday mornings, which is evident by the "children's message" (a time that continues to fill us all with joy). We have found continued growth in our youth activities and a continued need for our on-line worship offerings.

This last year also began our time of discernment and search for an additional pastor. The call committee was formed and got underway in the early fall and have been working very hard to find the right candidate to present to you the congregation and to join our team. This is an incredibly important and arduous process, as there are not as many pastors to choose from as there was were. However, we have faith that God will guide us in this process and soon we will be moving forward in unbelievable ways. Let us continue to keep the call committee in our prayers as they do their work. Their work is one of confidentiality and due diligence and we must put our trust in their leadership as we await what is to come. God is good!

In this time of transition we were also blessed to have a seminary intern for the summer months which was a breathe of fresh air and a huge help! We are excited to see where God leads Gavin Diehm and we pray our paths will cross once more along that journey.

There is so much to cover with this end of the year report that it is impossible to get to everything, but I must recognize the dedication and hard work of the staff of Paynesville Lutheran Church. We are blessed with staff members with a breadth and depth of knowledge that allows them to continue their amazing work while taking on additional responsibilities in the absence of a second pastor. Thank you to the staff of PLC for all that you do each and every day. A huge thankyou to all the ministry teams as well. Thank you to our church council, boards, committees, music teams and leaders, teachers, mentors and guides. It is not exaggerating when I say that the ministry that we share would not be possible without the selfless work done by so many.

2022 Congregational Report

God is at work in inspiring and life-changing ways at Shores of St. Andrew Bible Camp, Green Lake Bible Camp, and Camp House! As we processed what to include in this very brief report, it became clear that we were only going to have space to include a small snapshot of our year with so many of the details not fitting on the pages. In truth, the story of this year is the story of the ministries that work in partnerships with us. We give thanks for all of the ways that your ministry has impacted the work and mission we share. It has been such a joy to partner with you in such impactful and successful ways this year!

In this report, you will find a brief summary of our year, but please watch for our official Annual Report. This will be mailed out to congregations in January, before our Annual Meeting on February 14, 2022.

Program Ministry

It is such a blessing to share that this summer we served 345 more kids and families as part of our summer camp and day camp ministry than last year and reached 90% of our pre-pandemic numbers! Safe, fun, and impactful all come to mind when considering the summer and it seems that things will only progress as we look ahead to 2023. We heard great feedback surrounding the move of all youth summer camps to the Shores of St. Andrew Bible Camp site as well as ending the camp week with the "Campapalooza" all family event on Thursday evening.

Retreat ministries at GLLM bounced back in the summer after many slow months during the height of the pandemic with fall and winter bookings also looking strong! Confirmation groups, crafting retreats, education events, and our own programmed retreats have all made for busy weeks! In fact, between May 1st and December 1st there were only 4 days that we didn't have at least one group at camp! Although numbers are not finalized, we are projecting that we will host 1,100 more guests on site in 2022 vs 2021. It has been amazing to see so many of you on site this year!

Through the addition of "Serve Boldly" in the fall of 2022, GLLM has expanded its ability to do ministry across the country through service trips! Beginning in 2023, congregations will have the opportunity to book trips in Nashville, Chicago, and Milwaukee with more locations to come in 2024. We expect to serve 450 high schoolers in 2023 and 1000+ in future years. This is a big deal that only happens through the work and generosity of the Serve Boldly Founders who had vision for their organization's next move. We can't wait to see how God will use this bold ministry moving forward...

Properties

All three of our camps had significant projects taken on by our staff and volunteers this year. At Shores of St. Andrew Bible Camp, the final Cottage remodel was completed along with a major upgrade to our Health Aid Station. At Camp House, we contracted with a local forester to remove brush and trees from around buildings which will better prepare the site for inclement weather and fire, and a new beachside worship area was added. At Green Lake Bible Camp, work continues at the Stave Chapel. Landscape, concrete sidewalks, and grass planting were all major projects taken on. This year was also a difficult year for repairs and unplanned replacements. We replaced 2 furnaces, 2 air conditioners, did a major repair to an underground water leak, and replaced our bus totalling over \$100,000 of unplanned expenses.

Financial Position

Although our year end financials are not finalized as of the writing of this report, it seems that our total regular income will increase by \$400,000 versus 2021, but still miss our budget projections set at the beginning of the year. We missed income projections for summer camp based on having to limit our capacities in response to staffing shortages and retreat numbers that didn't meet expectations based on our overestimating of how fast demand would return in January through May.

Water's Edge Strategic Process

At our Annual Meeting a year ago, the GLLM corporation unanimously approved a capital campaign with proposed projects across all three sites and a signature project of renovating the retreat and conference center at Green Lake Bible Camp. We are well on our way with the lead gift portion of fundraising and will be sharing exciting updates surrounding our fundraising efforts and project start dates in the coming months.

I am so very thankful to the many of you who have welcomed myself and other GLLM staff into your homes to discuss these important initiatives. Thank you for sharing your passion for our work and your generosity towards the projects!

Closing

I truly believe that we will look back at 2022 and remember it as one of the most important years in the history of GLLM. Increased camper numbers and a drastic increase to retreat ministries - yes. But most importantly, new partnerships and relationships, new ministry opportunities, and big/inspiring projects will be the year's legacy.

As we consider the year ahead, we have so many reasons to be excited regarding what is to come. We are projecting increased participation across all our programs, we are set to start significant work within our capital projects, and we are excited to invest in new and existing relationships and partnerships.

The format of this report doesn't allow near the space needed to process the entire year nor thank all that contributed to its success. The almost 200 congregations and thousands of people who are connected to this organization are a special group. Thank you so much for partnering with us again this year as we share (together) the life-changing love of Jesus in vibrant settings in community and creation!



LSS creates life-changing connections with the people and resources needed to assure that all people can live and work in community with full and abundant lives, such as connecting families with deaf mentors who help deaf individuals and their parents see possibilities instead of limitations.

Lutheran Social Service of Minnesota is a movement of 25,000 – 2,500 employees, 10,000 volunteers, and 12,500 supporters — all of whom are critical to our successful support of the individuals and families seeking to change their lives through our services. I am pleased to share with you a sampling of what this movement has accomplished in the past year in every county of the state and beyond. This has been a year of strength, growth and innovations.

In Duluth, we celebrated the grand opening of the new LSS Bethany – Services for Children, Youth and Families. LSS has evolved services as the needs of youth and families in the community have changed, from Bethany Children's Home in Duluth, an orphanage that opened in 1916, to the Bethany Crisis Shelter, which offered emergency shelter care beginning in the early 1970s. Today, as part of LSS' statewide services for children, youth and families, the beautiful new LSS Bethany touches lives throughout northeast Minnesota and beyond with safe emergency shelter for children, as well as new early intervention and prevention services. These early intervention and prevention services include parent education and coaching, behavioral health, family visitation, and reunification support.

In Crosslake, we gathered at LSS' Camp Knutson for the groundbreaking of a new dormitory. Located in northern Minnesota, Camp Knutson gives campers with identified needs a life-changing experience of community. The new camper cabin is designed to better-welcome campers who use wheelchairs and accommodate other needs.

LSS continues to grow services that meet individuals and families where they are, and provide what they need, to change their own lives. One such service that creates greater independence and self-sufficiency is LSS Meals. Over the course of this past year, we've added two new production kitchens that have expanded our delivery of nutritious meals to not only older adults, but also veterans and children living with food insecurity.

Throughout the COVID-19 pandemic, most of LSS' employees continued to deliver in-person services — albeit with extra safety protections. Conversely, some services were most-safely delivered remotely. While the pandemic may not be over, we are transitioning to more in-person work as situations allow. It's been fun to witness the outpouring of warmth and joy between colleagues as they reconnect, or in some cases, eagerly meet newer coworkers face-to-face for the first time.

Even though students have not been physically in school for the majority of the 2022-23 school year, please know that your ongoing monthly sponsorship is still going toward their education.



As a board, we decided that it was important to continue paying our teachers and staff despite school not being in session.

Our staff leaned on what they learned during the pandemic shutdown and reenacted a **distance learning program** in October. Each teacher prepared learning packets and homework each week for parents to pick up and drop off for their students.

Families were thrilled to have this option so that their children can continue to learn, even if remotely.

- 3. Our marketing will intentionally and significantly reach outward to families who have no church affiliation and remain intent on delivering the gospel message in clear ways to demonstrate how faith can impact life and leadership. Expand our marketing and social media strategies to reach well beyond our traditional ELCA network focus by asking 'who is not at camp?' Who are we missing, and how can we reach them?'
- 4. We will seek to monetize our program offerings and pricing to ensure our annual operational costs are covered with camp and retreat income so that capital campaigns and planned giving donations will be used for scholarships, facility enhancements, camp expansion projects, and program development.

For we are co-workers in God's service; you are God's field, God's building."

- 1 Corinthians 3:9 (NIV)

One of the beautiful parts of synod ministry involves driving across this large territory and seeing the changing colors from one season to the next: bright yellow-greens of springtime, rich deep greens of summer, the golden crops in late summer, the brilliant colors of leaves in the fall, and then the rich dark soil of early winter.

In his first letter to the Corinthians, St. Paul describes the church in beautiful images: as coworkers in God's service, a field, and a building! As we look ahead to 2023, I consider the image of the church as a field.

You are God's Field

The first thing I want to say is, "Thank you!" Thank you for planting God's Word in the world and loving your neighbors as we move through the global pandemic. Thank you for the generosity you share to further partner and synod ministries during times of transition, challenge, and celebration. Whether lay or rostered leaders, we are coworkers for God's mission. We lead and serve in our various congregational ministries with the patience of gardeners and farmers, believing and trusting that it is God who gives the growth. I give thanks to God for you!

Planted Together

Our synod identity statement says God has planted our congregations in cities, farms, and towns together under one prairie sky, and that by God's grace, together we have what we need. As I visit our congregations and listen to rostered and lay leaders, several things are clear:

- Like the earliest Christian communities, congregations today from those in open country to larger cities and small towns are
 very different from each other! Paul's letters to those early churches reflect the unique circumstance of each. Our congregations
 today are emerging the pandemic each facing their own unique challenges and opportunities And so this is a time to listen to
 one another's hopes and concerns, seek to understand, and continue to remind each other that we are still in this together.
 What does it mean to know that we as churches are connected to each other today?
- God has given unique gifts to each congregation: the fruits of the Spirit (Galatians 5:22-23), and the gifts given to equip the
 saints for the work of ministry for building up the body of Christ. (Eph. 4:12). Lay and rostered ministry is not a solo endeavor;
 we are all partners because we are the body of Christ. Whose gifts might you discover and lift up as you look to the new year?
- Congregation identities have been shaped by the context in which God has planted us. That includes geography, and cultural
 and denominational histories. It also includes the mile-markers along the way: congregation and community crises,
 anniversaries, transitions, and the new things we have discovered over time. Post-pandemic, we acknowledge that we cannot
 retreat to some of the nostalgia or habits of the past. What is God calling you and your church to be and do in this new year?
- Our context also provides important signposts as we consider how God is calling us into the future. Our communities
 have changed drastically in the past few years. The needs of our neighbors are significant. Many congregations are
 partnering for new ministries of serving, faith formation, staffing, and worship. How is the Spirit leading you to be the
 hands and feet and smile and love of Jesus with others in your area today?

"God's demonstration plot"

When a seed is planted and tender shoots start to emerge from the soil, it's hard to imagine the plant that will grow there. Corn or beans, daffodils or iris bulbs, tomatoes or pumpkins.... from small beginnings grow plants that can be beautiful and sustain life. As we emerge from this global pandemic, we can see how the rate of change sped up innovation and creativity across our congregations. We see new fruit.

NOVEMBER 28: BACK TO CLASS

Students returned to school Monday, November 28. On that first day, there were 95 students and by Friday December 2, enrollment was up to 144. The students did not wear uniforms like all the other schools at that time in Haiti as a safety precaution. There was joy in the students' faces, because they got the chance to return to school and reunite with their friends.

The teachers continue to be hopeful and motivated to teach, despite the case of kidnapping and the dishonest acts and economic inflation that continues in the country. ANACS School Director, Mr. Baudelaire, reports, "We thank you from the bottom of our hearts for your support and prayers, as we never give up on our goal."

ANACS Fall Timeline Recap

SEPTEMBER 5: FIRST DAY OF SCHOOL

Classes at A New Arrival Center School (ANACS) started on September 5th, with 134 students, across grades 1-9, arriving ready to learn.

SEPTEMBER 12: SCHOOL START POSTPONED NATIONWIDE

After just a week into the school year, the **Ministry of Education postponed the opening of school until October 3rd**. This delay was based on insecurity within the country, the fuel shortage, and an economic crisis with rising prices. Our school staff agreed to plan for the lost days of instruction to be extended at the end of the school year if possible.

OCTOBER 2: NATIONAL SAFETY CONCERNS

In a press release on Sunday, October 2, the Ministry of National Education and Vocational Training (MENFP) recognized how "the first week of the 2022-2023 school calendar will be difficult for the relaunch of school activities in several parts of the country." They expected "a gradual and difficult back to school."

OCTOBER 5: MORE SAFETY CONCERNS REPORTED BY STAFF

Staff at ANACS recognized this difficulty, reporting on October 5th that "It is impossible to start school for the moment, because the climate does not allow. The danger is everywhere on the streets of the country. We thank you for thinking of us and for always keeping informed of the news. It goes straight to our hearts!

Every prayer counts because it is our only hope."

OCTOBER 7: REMOTE LEARNING PLAN ENACTED

The decision was made on October 7th to launch a remote learning plan. School staff worked together to prepare a package for each child with all the documents needed (books, notebooks, pens, pencils, etc...) and lessons prepared by teachers for each of the classes. Parents were contacted to come to the school to pick up materials. 85% of the students had materials picked up. The parents were very happy with this distance learning initiative. ANACS was the only school in their community that did not stop working in these difficult times that Haiti is going through.

OCTOBER 21 & NOVEMBER 16: PARENT MEETINGS HELD

On October 21st and again on November 16th, staff members met with families while they were picking up distance learning materials to gather feedback from those living in the community. Parents mentioned that the neighborhood is fragile, and they do not agree to risk their children's life sending them to school, because gangsters have gotten the control of almost all areas of Pernier. In the meantime, they also mentioned that they are satisfied with the program prepared for them.

One of my professors, Prof. Craig Van Gelder, wrote that growing up on a farm in rural Iowa provided a lesson for understanding the church being missionary by nature. Extension agents then would introduce new farming technologies, seeds, and fertilizers in strips of land along major highways that served as demonstration plots for these new innovations. Van Gelder writes, "The church is God's demonstration plot in the world. Its very existence demonstrates that his redemptive reign has already begun. Its very presence invites the world to watch, listen, examine, and consider accepting God's reign as a superior way of living." 1



As we move into new levels of activity in our congregations, it's easy to turn inward, wonder where the people have gone, and focus on scarcity and survival. Bur dear friends, many in our world are watching to see what kind of church we will be in the future. People in our communities long for healing and hope. I believe God is calling and sending this church to live out the way of Jesus for this time, in the context where we're planted. God's reign is breaking into our world, and in Jesus Christ God is reconciling the whole world to God's very self.

What's been going on in Haiti?

As an organization focused on education and hope, we often don't enjoy sharing the, often horrific and sad, realities of what our friends in Haiti are experiencing around them. However, we feel it is important to share these updates with you so you have insight into what our teachers, staff, students, and their families are going through.

Over the last few months:

Gang warfare has deepened, and reached many of the neighborhoods in which our staff and students live, since the assassination of President Jovenel Moïse in the summer of 2021

The prime minister **raised the price of fuel**, sparking protests of anarchy. A gang blocked the port through which most of the fuel comes into the country, leading to a crisis as everything in Haiti runs on diesel generators. When there's no fuel, it impacts almost every part of daily life.

Cholera is spreading, as it has before, partly because armed gang presence is preventing aid groups and doctors from providing care.

Kidnappings, targeting both rich and poor Haitians, happened at a rate of four a day in October, according to the U.N.

For the first time ever, **hunger has reached "catastrophic" levels** in the Cité Soleil neighborhood, which has left thousands facing famine-like conditions. While none of our students or staff live in Cité Soleil, we have heard that they are hungry because getting food has become extremely difficult due to increasing costs and unsafe streets.
